### § 114-1. Definitions of words and phrases.

- A. The words and phrases used in this chapter shall, for the purpose of this chapter, have the meanings respectively ascribed to them by Article I of the Vehicle and Traffic Law of the State of New York.
- B. The following words and phrases which are not defined by Article I of the Vehicle and Traffic Law of the State of New York shall have the meanings respectively ascribed to them in this section for the purpose of this chapter.

CURBLINE – The prolongation of the lateral line of a curb or, in the absence of a curb, the lateral boundary line of the roadway.

HOLIDAYS – Includes such days designated as public holidays as provided in §24 of the General Construction Law.

OFFICIAL TIME STANDARD – The time standard which is in current use in this state whenever certain hours are named herein or on traffic control devices.

PUBLIC PARKING LOT – A plot or parcel of land or building owned and/or leased by this village, not including highways, upon or within which the parking of vehicles is regulated by signs.

## § 114-2. Authority to install traffic control devices.

The Street Foreman shall install and maintain traffic control devices when and as required under the provisions of this chapter to make effective the provisions of said chapter.

## § 114-3. Delegation of powers to Mayor to regulate traffic.

Pursuant to the provisions of §1603(a) of the Vehicle and Traffic Law of the State of New York, power is hereby delegated to the Mayor to exercise, by official order, rule or regulation, all of the powers granted to the Board of Trustees of this village in Article 16 of the Vehicle and Traffic Law, subject, however, to the limitations imposed by §§1645 and 1684 of the Vehicle and Traffic Law of the State of New York.

## § 114-4. Authority of the Police Department to regulate traffic.

- A. Pursuant to the provisions of 1602(b) of the Vehicle and Traffic Law of New York State, the Police Department is hereby authorized to prohibit temporarily the parking of vehicles on any highways or portions thereof within the village during the time of an assembly, special event, parade, snow emergency or other similar circumstances, notwithstanding the provisions of the Vehicle and Traffic Law of New York State or of local laws or ordinances.
- B. The Sergeant of Police shall, in the exercise of its powers as set forth in Subsection A herein, cause appropriate signs to be temporarily erected, whenever necessary, to adequately advise all persons of such temporary changes.

### ARTICLE II

#### Penalties

#### § 114-5. Penalties for offenses.

Any person who shall violate any provision of this chapter shall be subject to a penalty as set forth in Chapter 1, General Provisions, Article II, General Penalty.

## ARTICLE III

## **Traffic Control Signals**

### § 114-6. Littering of streets and sidewalks prohibited.

Traffic control signals shall be installed, maintained and operated as follows:

- A. A three-section, four face signal head at the following intersections:
  - 1. Main Street with Mill Street.
  - 2. Main Street with Maple Avenue.

#### § 1114-7. Stop intersections.

The intersections listed below are hereby designated as stop intersections, and stop signs shall be erected on entrances thereto as indicated.

## § 114-8. Maximum speed limits.

Thirty (30) miles per hour is hereby established as the maximum speed at which vehicles may proceed on or along highways within the corporate limits of the Village of Sodus or as otherwise provided.

### ARTICLE IV

### Parking, Standing and Stopping

#### § 114-9. Application of Article.

The provisions of this Article shall apply except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device.

### § 114-10. Parking, standing and stopping restrictions.

Parking, standing and stopping restrictions shall apply on the following highways as follows:

A. There shall be no parking restriction on the following highways:

# § 114-11. Handicapped parking.

Only handicapped persons shall have the right to park in those parking spaces hereinafter designated. Such handicapped person shall obtain a handicapped parking permit. Any handicapped person possessing a valid permit issued by a Police Department or other agency under the laws of the State of New York or any other state and displays such permit shall be entitled to such parking. The following parking spaces are hereby designated for handicapped parking:

- A. The first parking space west of Marine Midland Bank on the north side of West Main Street.
- B. The parking space on the north side of Main Street from the west curb line of East Main Street.

## ARTICLE V

#### **Time Limit Parking**

## § 114-12. All-night parking.

The parking of vehicles is hereby prohibited on all highways within this Village from November 1 until April 1 between 2:00 a.m. and 7:00 a.m.

## § 114-13. Parking time limits on streets.

The parking of vehicles is hereby prohibited for a period of longer than two hours, from 8:00 a.m. to 6:00 p.m., except Sundays and holidays, as follows:

- A. The designated parking areas are located in the Core Business District (West Main, East Main, Maple Avenue, and Mill Street)
- B. Parking front of the municipal building will be limited to official business for a time limit of five minutes only during normal working hours.

## § 114-14. Parking time limited in municipal parking lot.

Twenty-four hour parking only shall be allowed in the Municipal Parking Lot.
